Plans Submitted to the City: Majors Golf Club May Be Lost to Development

Officials at City Hall have notified HOA President Robert Stise that they have received applications for a large-scale comprehensive plan amendment, **rezoning**, and preliminary Planned Unit Development (PUD) for the property adjoining Summerfield. The plans call for elimination of the golf course and replacing it with 367 small single-family residences. The applicant is the current owner of the Majors, Heather Joyner (Joy, LLC). The developer is Kolter Homes.

We are firmly opposed to losing this property to development and are organizing a challenge to the zoning change. Just outside SF, Stonebriar is in the latter stages of building 328 homes. The addition of 367 home *immediately adjacent* to our properties will cause us a *severe negative financial impact* and further diminish our *quality of life* (noise, infrastructure, environment/wildlife, traffic, potential accidents, schools, and City services).

We want to inform everyone in SF and involve anyone wishing to join us in opposition to the zoning change. Our success depends on how many residents

join the effort and how convincing we are in building and presenting our case.

Two Changes to SF Covenants Approved by Homeowners

Two changes to the Summerfield Covenants were overwhelmingly approved at a special meeting of the members on January 18. Proxy votes were received from 131 Summerfield homeowners.

A change to the landscaping section was approved with 122 voting in favor and 9 opposed. The change provides homeowners with some options when landscape changes become necessary. This change should improve neighborhood safety and reduce overall cost of ownership.

The second change related to regulations on garages; it was also approved with 123 voting in favor and 8 opposed.

The changes were recently recorded by the State of Florida and can be immediately implemented. Homeowners will receive a notification of the changes in the US Mail sometime in late February or early March.

Homeowners are reminded that any changes to landscaping or garages require the approval of the Association. While the Covenants now allow more flexibility on the part of property owners, approval from the Architectural Review Committee (ARC) must be secured before work can begin.

Please double-check the revised Covenants (article II, section 5) to make sure you have the minimum number of trees required for your property when you submit an ARC form for landscaping changes.

Speed control

President Stise reported at the last HOA Board meeting that we will continue to monitor speed compliance and some people have slowed down. Alternatively, there have been some contentious discussions where speeders have been called out by people walking on the street. Robert suggested if we see people egregiously speeding, we should identify the vehicle and report it to our Property Manager, Joy Simon (email: joy@fairwaymgmt.com).



We will also get the Palm Bay Police radar trailer again soon. Your HOA Board has contracted to have a Palm Bay Police Department officer work in SF from time to time, monitoring traffic with radar and stopping violators. We are looking

for voluntary compliance but if we can't achieve the 20MPH safe speed limit in Summerfield, speed bumps will be installed.
