A Great Place To Live Proposed Changes to Summerfield Covenants: Proxy Ballots Delivered

The HOA Board has scheduled a special Zoom meeting to address the changes to the SF Covenants proposed last month. The meeting will be held on Tuesday, January 18 at 5:30PM.

A proxy ballot package was delivered in mid-December via US Mail to each homeowner address. The package contains:

- 1. a letter from HOA Board President Robert Stise, explaining why the Board has proposed these changes;
- 2. detailed amendments proposed to the landscaping and garages sections;
- 3. the agenda for the Special Meeting January 18 with Zoom contact numbers; and
- 4. one Proxy ballot with instructions on how to vote.

The Board requests that you carefully consider these proposals which are designed to improve sidewalk safety, reduce overall homeowner cost of ownership, and provide some flexibility to residents when landscaping changes become necessary.

<u>Please read and consider the item on page 2 related</u> to a large lawsuit settlement awarded to a Melbourne resident who suffered serious injuries in a sidewalk fall inside her HOA community.

Florida Today Report: Jury awarded \$957K to a Melbourne HOA resident for Sidewalk Fall

Florida Today reported that Brevard County and the Grand Master Homeowners Association of Melbourne were sued because they failed to adequately maintain a sidewalk in their subdivision and failed to warn pedestrians of the hazard. A resident, represented by Morgan & Morgan, was injured in a fall on an uneven sidewalk causing her serious brain injuries. A jury awarded her nearly \$1M in the case in December of 2021.

Dangerous heaving sidewalks in Summerfield caused by oak tree roots in the green belt exposes our Association and our homeowners to the same liability.

We recognize that we share the same responsibilities and risks and want avoid lawsuits. A "yes" vote for the oak tree Covenant change will help everyone in SF avoid injuries and potential litigation.

2022 Budget Established with 5% assessment increase

The Summerfield Board of Directors approved the 2022 operating budget in the December meeting. Initially the Board wanted to hold the assessment dues flat to last year. With inflation rapidly rising, we have seen cost increases in every line item in the budget and the Board conceded that it could not hold assessments flat to 2021. The Board approved a 5% increase in dues from 2021 to 2022 and believes that should be adequate to keep the HOA in good shape financially for 2022. It includes a small cushion to cover some cost increases that may materialize later in the year. HOA annual dues must be paid by the end of January.

Another Accident at the Dangerous Curve (near our gate)

A serious motorcycle accident occurred at the sharp curve on Bayside Lakes Blvd on Jan 1. At about 8PM, a helmetless biker travelling much faster than 30MPH failed to negotiate the curve and crashed. The biker was taken by Medivac helicopter to a medical facility. This is **another sad reminder about the hazards of excessive speeds at the curve** where accidents have taken at least four lives and countless injuries have been sustained. Board President Robert Stise has been speaking at City Council meetings, asking for changes and speed enforcement to address the situation. He plans to push for the Council to take decisive action at the next meeting.

Speed control

The HOA Board continues work on awareness and enforcement to get drivers to follow the 20 mph speed limit. Shortly after Thanksgiving, the message board at the SF exit gate displayed a message hinting at the possibility of adding speed bumps. The Palm Bay Police radar trailer was installed near the Windbrook bridge a few days later. Your HOA Board has contracted to have a Palm Bay Police Department officer work in SF from time to time, monitoring traffic with radar and warning speeders. We are looking for voluntary compliance. If we can't achieve the 20MPH safe speed limit in SF, speed bumps will be installed.

When your dog poops on or near the sidewalk or the driveway, in the green belt, along the road, or on your neighbor's lawn,


<u>clean it up</u>.
